Sealed bids, subject to the conditions contained herein, will be received by the Municipal Airport Authority at their office located on the second floor of the terminal building of Hector International Airport until 10:00 AM on the 13th day of October, 2015, and will be publicly opened and read aloud.

Payment will be made for mobilization, demolition, earthwork, sanitary sewer, ramp lighting, street lighting, overhead lift gate, geotextile fabric, aggregate base course, PCC pavement, joint sawing & sealing, aircraft tethers, pavement markings, seeding, mulching and incidentals.

Each bid proposal shall be made out on the form contained within the project specifications and placed in a sealed bid envelope. In a <u>separate</u> bid security envelope, the proposal must contain a bid bond executed by a corporation authorized to contract as a surety in the State of North Dakota in an amount not less than 5% of the bid amount. The bid security should be made payable to the Municipal Airport Authority and must not contain any conditions either in the body or as an endorsement thereon. The bid security shall be forfeited to the Municipal Airport Authority as liquidated damages in the event the successful bidder fails, or refuses to, enter into a contract within fifteen (15) days after the award of contract and the maintenance of said work, if required, pursuant to the provisions of this notice and other contract documents. Attach bid security envelope to outside of bid envelope.

The 5% Bid Security of the three lowest bidders will be retained until the contract is executed, but in no event longer than 30 days, provided that the Bid Security of the lowest responsible bidder shall be retained in any event until the contract is executed and Contractor's Bonds furnished as herein provided. No bidder shall, without the consent of the Municipal Airport Authority, withdraw his bid for a period of 30 days after the date for the opening thereof. The bid of the lowest responsible bidder will be accepted on or before the expiration of 30 days after the date of the opening of bids.

The successful bidder will be required to furnish separate performance and payment bonds in amounts equal to one hundred percent (100%) of the contract price, said bonds to be issued by a responsible surety approved by the Municipal Airport Authority.

All bidders are required to have a North Dakota contractor's license of the proper class and the bidder must hold the license at least 10 days prior to the date of the bid opening. A copy of the license, or renewal certificate, shall be included in the bid security envelope.
