Hector International Airport Notice of Intent to File a PFC Application July 26, 2017

The Municipal Airport Authority (Hector International Airport) is planning to file an application with the Federal Aviation Administration (FAA) to impose and use a Passenger Facility Charge (PFC) to fund capital improvement projects. This notice is being issued to meet PFC application filing requirements set forth in 14 Code of Federal Regulations (CFR) § 158.24. The proposed charge is \$4.50 per enplaned passenger effective March 1, 2018 and estimated to expire on March 1, 2020. The total revenue to be collected and used by the Airport at the end of the collection period is \$3,305,146.99 and will fund:
